State the PHA’s mission for serving the needs of low-income, very low-income, and extremely low-income families in the PHA’s jurisdiction for the next five years.</p> <p>The mission of the Red Bank Housing Authority is to provide safe, decent, attractive, accessible, and affordable housing for eligible families, and to provide economic development opportunities to improve the quality of life. The Red Bank Housing Authority will also establish and maintain partnerships with residents and public and private entities to this end. The Red Bank Housing Authority is committed to operating in a cost-efficient, ethical, and professional manner.</p>
B.2	<p>Goals and Objectives. Identify the PHA’s quantifiable goals and objectives that will enable the PHA to serve the needs of low-income, very low-income, and extremely low-income families for the next five years.</p> <p>Montgomery Terrace (built in 1960) and Evergreen Terrace (built in 1969) have fundamentally flawed design and structural deficiencies which negatively impact the daily lives of its residents. Red Bank Housing Authority’s (“RBHA”) efforts to maintain and repair the obsolete developments are futile based upon a cost-benefit analysis. However, through partnerships with Montgomery and Evergreen resident councils, the concerns of RBHA residents will be represented and heard throughout the planning effort from community engagement strategy to needs assessment, visioning, recommendations, decision making, and anticipated redevelopment, including the appropriate conversion of public housing.</p>

Include a report on the progress the PHA has made in meeting the goals and objectives described in the previous 5-Year Plan.</p> <p>Obtained municipal grant for pre-development costs to identify and assess potential infrastructure projects and modifications to its existing infrastructures, and to advance those projects from the conceptual phase to actual redevelopment.</p> <p>Implemented concerted employee training to improve customer service, increase knowledge of HUD regulations, enhance the provision of maintenance and repairs, and ensure Fair Housing compliance. In addition, enhanced training included optimal use of tenant reporting system, HUD systems (i.e., PIC) and working knowledge and application of updated ACOP and Administration Plan.</p>

In furtherance of its Fair Share Affordable Housing obligations, the Borough recently entered into a \$350,000 Grant Agreement with RBHA. The \$350,000 grant, earmarked for pre-development costs, will be used to identify, and assess potential infrastructure projects and modifications to its targeted housing, and to advance those projects from the conceptual phase to actual redevelopment; and with the award of the Planning Grant have the opportunity to transform a racially and ethnically concentrated area of poverty into an area of opportunity, which fosters and maintains compliance with fair housing and civil rights.

In addition, the Housing Authority has applied for a 2023 Choice Neighborhood Planning Grant which leverages the \$350,000 Grant.
